



## NZAMI Membership Categories and Fees for Off-shore Members

*(All fees are quoted in New Zealand dollars and are exclusive of GST)*

**Application Fee** - All categories: NZ\$50.00

**Web Link Levy** - One per organisation: NZ\$25.00

### Full Membership

- For IAA Licensed Advisers who have held their IAA license for a minimum of 2 years at the time of making their application for membership to NZAMI
- For Exempt Advisers who are in the business of giving immigration advice e.g. Lawyers
- Full Membership is for individuals, not organisations

**Full Principal Membership** - Annual Fee: NZ\$500.00

- There must be at least one Full Principal NZAMI Member in any one organisation
- Full Principal Members enjoy all the benefits of membership, including full voting rights and eligibility to serve on the Board
- There is no limit to how many Full Principal Members any one organisation can have as members of NZAMI

**Full Non-Principal Membership** - Annual Fee: NZ\$200.00

- Provides a discounted fee for Full Members, who may apply if there is at least one Full Principal member in the organisation
- Full Non Principal Members enjoy all the benefits of membership at a discounted fee, excluding full voting rights and eligibility to serve on the Board

**Primary Membership** - Annual Fee: NZ\$300.00

- For IAA Licensed Advisers who at the time of making their application for membership to NZAMI have held their IAA license for less than 2 years. A Primary Member shall become a Full Principal or Full Non Principal Member after being a Primary Member for a period of 2 years provided that he or she has attended a minimum of ten NZAMI Continuing Professional Development events (to include attendance in person or purchasing a recording of a seminar, webinar, workshop, cell group meeting or annual conference in the preceding 2 years).
- Primary Members enjoy all the benefits of membership at a discounted fee, excluding full voting rights and eligibility to serve on the Board



## **Student Membership** - Annual Fee: NZ\$200.00

- For students who have been accepted onto the Bay of Plenty Graduate Diploma in New Zealand Immigration Advice (Level 7) or any subsequent qualification mandated by the Immigration Advisers Authority as a prerequisite to becoming a Licensed Immigration Adviser.
- Student Members enjoy all the benefits of membership at a discounted fee, excluding full voting rights and eligibility to serve on the Board

## **Associate Membership** - Annual Fee: NZ\$300.00

Associate Members enjoy all the benefits of membership, excluding full voting rights and eligibility to serve as a Director.

### **Category 1**

- For organisations with an interest in immigration but who are not in the business of providing immigration advice
- One person must be nominated to act as the organisation's representative

#### Evidence Required

- A resume from the nominated representative
- A copy of the business registration

### **Category 2**

- For individuals who are Exempt Advisers and for whom the giving of immigration advice is either not their primary role or is not undertaken for financial gain e.g. lawyers who do not practice immigration work; Community Law Centres; employees of Citizens' Advice Bureaux

#### Evidence Required

- Two professional references from contactable referees

### **Category 3**

- For individuals who wish to remain informed on immigration matters but who are ineligible to give immigration advice at the time of application e.g. those working towards applying for an IAA Provisional Licence

#### Evidence Required

- Two professional references from contactable referees

## **Honorary Membership**

Members may confer by majority vote Honorary Membership for a term of two years on any Full Member who has made an outstanding contribution to the NZAMI.

## **Life Membership**

Members may confer by majority vote Life Membership on an individual who has made an exceptional contribution to the NZAMI.
